### **CARL FISCHER®**

#### **Program Notes**

Founded in 1977, the Houston Concert Band is an all-volunteer organization of over sixty Houston-Area musicians high school age and older and is currently under the direction of Chuck Throckmorton, Director of Bands at Rice University. Dedicated to the 30th season of the HCB, *Fanfare and Patrol* was premiered at the 2007 Houston-Area Community Music Festival. The opening annd closing "Fanfares" featuring the brass and percussion (mm. 1-26) and the entire ensemble (m. 75) should be played with all the energy and gusto the word "Fanfare" suggests. The stylistic indication Patrol suggests a band passing in review. Heard faintly in the distance (m. 29), the band appproaches gathering momentum and volume, passes in review (m. 49) and quietly continues on its way (mm. 65). The echo effect of the sixteenth-note figures as they are bounced among the sections of the band should be seamless and treated as one long extended line.

#### About the Composer

As a major composer of instrumental and vocal music, Carl Strommen is recognized as one of the most often-performed composers of educational music in the United States.

A graduate of the City College of New York, Mr. Strommen was the Director of Bands at the Mamaroneck Public Schools, Mamaroneck, New York for many years. He is a member of the faculty at the CW Post campus of Long Island University, where he teaches orchestration and arranging. Recognized by ASCAP as a consistent writer in the Standard Awards category, Mr. Strommen is also active as a clinician, lecturer and guest conductor.


